- 1. September 24, 2025 Board of Directors Meeting Voting Results:
 - A committee called the Governing Documents Review Committee (the "GDRC"), was created. The vote was 3-0 in favor. Motion passed. We are now looking for volunteers to assist us with updating the Governing Documents---including our Rules and Regulations. Our intent is to have Governing Documents that are clear, sensible and able to be enforced. You do need to have a legal background. Just have common sense, creativity and fairness.

2. Irrigation

- Sprinkler Timer serving 2286 SBD-Saratoga Lane had an electric problem. That problem has been rectified.
- A valve and timer issue is still affecting some areas of the North End by 2352 SBD. Replacements ordered. Planning to have irrigation back on by Saturday, the 4th.
- Cypress Tree Circle valve issue was corrected.
- Image Sprinkler is still trying to identify the location of valves along Saratoga Road.
- Please have your sprinkler vendor maintain your rear yard sprinklers.
 Clogged heads prevent us from reaching the maximum water pressure throughout our system.
- 3. Sidewalks: Paul, Soo, Stephen and Jay weather permitting, will pick up the sidewalk inspections next week.

- 4. Right Exit Gate: The bolt was stripped and we needed to have a new bolt installed into the sleeve of the arm. Kind of like Tommy John surgery for gates. That is why it was dangling a week to two weeks ago.
- 5. Trees: Paul, Soo and Jay met with Only Trees to discuss tree conditions and to amass a plan over years. Trying to have Only Trees assess the neighborhood trees this month in time for our 2026 budgeting.
- 6. Bright Ideas Committee: Stephanie and Donna offered up the idea of having benches in the community area by 2271 SBD. Stephen Frankel took it one step further by asking to look into a gazebo. Any other thoughts?
- 7. Village Paws Dog Park: Budget cost overrun of \$150,000 has put a temporary halt to the renovation. The city is still committed to having the renovation completed. They are looking to reallocate funds.
